# **BLUEPRINT/Neighbourhood Plan**

#### **West Parade**

BT have filled in the hole and removed all barriers. The pavement outside the shop is not being maintained as customers are parking on it. If you were to have an accident you would need to sue the owners not the Council.

### Football Pitch - Redford Avenue

No update as yet. Mr Dufton will try and ascertain how many teams play and what league they play in.

# Planning application 89 North Parade

We lodged an objection to the size of this extension on the grounds of size. Amended plans have now been submitted, the footprint is unchanged, the ridge lowered with a flat section along the ridge. This does not look right. Mr Moore will object to the amended plans on appearance and overdevelopment.

Mr Dufton has concerns over the artist's impression of the redevelopment of the Wilko site. Councillor Crosbie said that it was difficult decision and the Council had got them to make some changes. Denne NHC did object on the appearance of the redevelopment.

Mr Moore has had a lady contact him about our vacancy, she is hoping to come to the March meeting.
