3/391/17 Matters arising

Mr Dufton informed members that former member of TNC, Frank Gibson, had passed away. Both he and Mrs Harris will attend the funeral. He was a popular business man in the town and ran Gibson Refrigeration for many years. Following his retirement he continued to work from home. He was a member of TNC for more than 25 years. He worked hard to get the plans for the Hardy Close parking scheme drawn up and approved.

Coaches in Farm Avenue

No update at present.

Pavement at Collingwood Batchelor

Councillor Dennis reported that all faults had been inspected and those that met requirements would be mended. Collingwood Batchelor have been sent a notice advising that they need to apply for a proper crossover and permission for vehicles to park on the forecourt with properly constructed dropped kerb.

Traffic lights at Malt Shovel

Councillor Dennis will report the fault.

Newsletter responses

Councillor Dennis advised that he is gradually getting replies to the highways queries from our recent newsletter. He will reply direct to the residents and copy us in all his replies.

Meeting with Adam Charmers – HDC

Mr Boffey attended on our behalf. A brief summary follows-

There is still an ongoing investigation into who owns the land at the railway subway. The Parks department are looking into a plan for entry and exit points into the park – the subway being one.

Horsham Year of Culture 2019 – there have been over 70 expressions of interest from around the District for funding, a great opportunity to get people working together.

Remembrance Day 2018 will mark 100 years since the end of WW1, what else could we do as a town to commemorate this.

Feedback received on the Ice Rink in the park has been 62% positive, 22% negative and 16% neutral. The main concerns were over parking and the future use of the site. The planning application for a hard standing has been withdrawn.

An 'off shoot' group of Friends of Horsham Park have met with HDC. Denne Council already have a memorandum of understanding for the park. It would be a good idea for the groups to work together.

Town Vision – hanging baskets will be reintroduced onto street poles in the town. The talk of redeveloping the Royal and Sun Alliance Car Park with access through New Street Gardens is an idea. No planning application has been submitted.

Street Wardens – HDC are concerned about anti-social behaviour. There idea is to have 2 new Street Wardens who would work a 37.5 hour week. There would be a 2 year trial costing £130,000. HDC would fund £30,000 with the rest coming from the Special Charge. The preferred option for funding would be that the current special charge that goes to the Drill Hall would go to pay for the Wardens. The Special Charge would not increase to pay for this. Are members happy to support this action -4 yes, 1 abstention.
