#### Noticeboard in the Rec

Mr Davis asked the Councils permission to purchase another key so that he and the Clerk can both have one. All agreed. Linda Cheeseman has asked if the Neighbourhood Council can take responsibility for them. This is not a financial undertaking, just a contact for putting leaflets in. Mr Davis will get more details but all agreed in principle.

## **Bus Route – Dog and Bacon Green**

A resident had contacted Councillor Dennis about the problem stating it's not residents causing the problem but people parking for the shop or going into town.

The bus company said they will support us in trying to get something sorted. We will need to look at a Community Traffic Regulation Order application.

#### **BLUEPRINT**

Mr Boffey attended the last meeting which focused on the selection and appointment of the consultant. All 3 will be invited to discuss their expression of interest with the steering committee. Before seeking funding there needs to be a clear picture of the costs involved to complete the process. The aim is to complete the plan this year.

#### **Street Wardens**

The Dec/Jan report has been circulated. The Wardens have been speaking to people parking in Greenway and have issued 3 parking alerts and spoken to 6 parents about safer parking in the area. Councillor Dennis will look into what can be done in the area through the CPZ.

There is a drug problem in the Rec that the Police were unaware of.

The Wardens completed a litter clear up in the Rec, this is not there job. Councillor Crosbie will find out if there is a cleaning schedule for the Rec.

There is concern over mobility scooters going fast in the town. They are only allowed to go 4mph on the footpath and 8mph on the road. Motorised scooters are not allowed to be used unless on private land.

## **Special Charge**

Mr Davis had attended a meeting with the 2 other chairs and Dominic Bradley to look at the draft special charge for next year. The biggest increase is the cost of the Street Wardens. The towns Christmas lights are up for tender this year as is the Youth contract.

## Youth meeting

The next meeting is on the  $15^{\rm th}$  January. Mrs Little will attend this as her last meeting.

## **Quarterly Neighbourhood meeting**

The next meeting is on the 15<sup>th</sup> January. Mr Boffey will try and attend.

Mr Dufton wondered if a star could be added to the lights. He will investigate and get costs.

## **Emergency Winter Plan**

The Town Wardens had asked what their duties are under the plan for the Trafalgar Ward. We haven't seen a plan for many years, neither have the other Neighbourhood Councils. Councillor Crosbie will investigate why we are not receiving them.

### **Speed Checks**

The old Speed indicator devices have been replaced by guns which cost £500 and £500 for the tablet to monitor and record numbers, totalling £1000. Could the 3 Neighbourhood Councils look at getting one to share? Mr Davis asked permission to gather more information. A grant of £500 is available. Denne are not keen to be involved. Mr Davis is happy to operate it on our behalf. All agreed for him to gather more information.

### **Town centre Christmas tree**

The tree was put up by charities and not HDC at a cost of about £1100. If HDC were to match the charity donation the cost would need to be added to the Special Charge or Neighbourhood Councils could donate. Members feel that this benefits the whole town so why should the unparished area be

the only ones contributing to it. There was no support for the proposal.
