The Rec

Mr Davis has had a good look at the Rec and lack of maintenance appears to be a problem – is it worth us spending money on the area if it is not going to be maintained. Mr Davis will have another look at the area and report back.

Bus Route - Dog and Bacon Green

The Clerk has not submitted an application due to no evidence being submitted and the fact that the bus company have now changed the route to go straight along North Parade and not along Trafalgar Road. The Town Wardens will keep an eye out for inappropriately parked cars.

Speed device

Mr Davis has training tomorrow in the Forest Area. We are still waiting to hear if Denne wish to be involved. There is a Neighbourhood Watch group in Wimblehurst Road who are very keen to be involved. They could be affiliated to our group.

Blueprint

Town Wardens

The August report is only a provisional one but has been circulated to members. The report will not be added to the website until the approved version is available.

Newsletter

The newsletter has been completed and delivered.

Mr Davis thanked the Chair for another very good newsletter. An error was made on the quantity of newsletters ordered by Mr Davis. Mr Davis has said he will cover the extra cost involved himself.

Gated properties have not been delivered to. Copies are available for residents to pick up from Londis and the Newsagents.

We will need to find someone else to deliver the newsletters next year.

Horsham in Bloom

We have had the invoice for the railing planter. The Treasurer will arrange payment of £165.

Mr Bryant put forward 1 Park Rise as the winner of the Trafalgar Cup. All members agreed with this and to give the winners a £20 garden centre voucher. Mr Boffey will check that this is what the other Neighbourhood Councils are doing.

Highways

Redford Avenue has been cut back and so has Irwin Drive. 60 Guildford Road does not meet intervention levels.

We have a balance of £10,225.07.

Cootes Pond

Over time the pond starts to silt up due to over overhanging vegetation. It is not appropriate to have large equipment to dredge the pond. Vegetation needs to be kept under control. They have had a quote for annual work of £400-£500. Do we make a donation of this amount as a one off to help them get back on track? All members agreed that as long as it is made clear that this is a one off donation and that they need to look at raising funds going forward.

8/410/19 **Highways**

The path from Caterways across the green to Merryfield Drive is very uneven.

The Pavement on the corner of Merryfield Drive and Fairview is broken up due to vans parking there whilst building work is being carried out. Will they be responsible for making good the damage?

Councillor Dennis asked if we had had the email from Horsham Society re twittens. No. Councillor Dennis will forward it on.

HDC have issued an enforcement notice on a trailer parked on the footway in Farm Avenue that has caused concern from residents. HDC are trying to set up a multiagency meeting to see what can be done to resolve the problems.
