# ASB/crime/criminal damage

#### Denne –

- 7 x Joint patrol with Police Community Support Officers (PCSO).
- Assisted a PCSO to deliver matrix letters to residents of the Highwood estate to encourage reporting of antisocial behaviour (ASB).
- Issued 4 banning notices from the multi-storey car parks for damage caused and updated the necessary ECINs (secure online information sharing platform) cases.
- While on a joint patrol, a group found smoking and loitering in an emergency exit stairwell were asked to leave and were advised on the covid breach (Forum). 4 banning notices were issued and ECINs cases created. One of the people that gave their details had been seen on CCTV footage on a previous date snorting a line of powder, the police were made aware of this information and the footage sent over.
- Signposted a resident to contact the police over a person they saw begging and did not believe to be genuinely homeless (West Street).
- 3 x ECINs cases updated for individuals begging in the town (West Street).
- Police report made for a person begging in breach of a police issued Community Protection Notice (CPN)
   (Legal document outlining prohibited behaviours) (West Street).
- Police report made for damage caused to doors on the back of the Office Outlet store in Horsham.

# COVID

- Replaced the site closed sign at the pump track.
- Spoke to 2 people at the pump track and advised on its closure (Highwood Pump Track).
- While on a joint patrol, 4 users of the pump track ran from the site as we approached. They had parked a vehicle by the entrance of the pump track. A parking alert was issued. The car was then seen being driven

dangerously when leaving the Highwood Estate. The police are making further investigations for action to be taken against the driver. A statement was provided to support the dangerous driving observed.

- Asked 1 person to leave the ball court as it is closed during the current covid restrictions (Needles).
- 21 people asked to leave outdoor gym (Horsham Park). 3 x Replaced the sign and tape showing it is closed. 1 police report made for a male that refused to leave or provide his details.
- 21 people asked to leave ball court (Horsham Park). Replaced the sign showing it is closed.
- 6 people asked to leave the skate park (Horsham Park). 2 of this group were arrested by the police for other offences. 8 other users ran from the site as they saw us approaching.
- A group of 3 were spoken to about meeting socially (Horsham Skate Park).
- A group of 8 were spoken to about meeting socially and were asked to leave (Horsham Park).
- A group of 4 were spoken to about meeting socially and were asked to leave (Causeway). On another
  occasion 2 of this same group had been spoken to previously for meeting for social reasons and not adhering
  to social distancing rules. The group refused to adhere to the advice given so a police report was made and
  details passed on.
- A group of 4 were spoken to about meeting socially and were asked to leave (Forum).
- Disrupted a group of 8 meeting socially in Piries Place car park while on a joint patrol with a PCSO. Their details were taken and they were told to go home separately.
- Disrupted a group of 4 meeting socially in Piries Place car park while on patrol with a PCSO. They were under 16 so their details were taken and parents called to come and collect them. The group and parents were advised on the breach of covid regulations.
- Made enquiries on behalf of a business to trading standards regarding reports that another business has been trading directly with members of the public during a time when this has been restricted.
- Checked the situation of a group of approximately 30 children playing rugby in Horsham Park, they were an after school club which was allowed.

#### Forest –

- Joint patrol with a PCSO and Special Constable.
- Sent photographs of a person taking a directional footpath post from Leechpool/Owlbeech Woods to the Neighbourhood Policing Team to try and identify those responsible for the post to be returned.

### COVID

• 10 people asked to leave the Bennetts Field ball court and were reminded of the current rule that only groups of 2 can exercise together.

# Trafalgar -

- Disrupted and challenged 2 males suspected of smoking cannabis (Victory Road Recreation ground).
- Request made to have logs removed from an area of the Riverside walk where groups are gathering (behind Redford Ave football pitch).
- 3 X Joint patrol with a PCSO.
- Repaired the report ASB sign (Redford Avenue).
- Forwarded information regarding possible drug dealing by a bench along the riverside walk to the police and reported the associated ASB with the parks team to look into what can be done to target harden this area.

#### Denne -

- Issued parking alerts:
  - Boulevard/pump track (no parking area, also informed the pump track is closed). The police will also be taking further action to contact the driver as they were seen driving dangerously as mentioned in the ASB section of the report.

- Repaired a sign providing information about double kerb stripes and double yellow lines (Queensway).
- Asked the driver to park elsewhere:
  - Queensway obstructive of the junction

### Denne -

   Support was offered but not enough details could be provided to engage fully (West Street). This person was engaged with on 3 separate occasions this month. Information was passed onto the police and Homeless outreach workers over concerns of possible exploitation and/or modern slavery.
- Reported a scooter that is on the roof of a building (West Street).
- Reported traffic lights that were not working to Telent (Worthing Road).
- Reported a streetlight that is on during the day (Causeway).
- Reported the trade waste bins are being stored in an incorrect location to the HDC Waste Team (Forum).
- Made the properties team aware that superficial damage has been caused to the doors on the back of the closed Office Outlet store, a police report was also made for the damage.
- Requested two new traffic signs to replace faded signs (Richmond Road).
- Reported as broken:
  - 3 x Fencing surrounding the skate park (Horsham Skate Park)
  - Failed repair of lighting (Anchor Court)
  - o Broken drain pipe (Medwin Walk)
  - o The casing for a post is in need of repair as it has come loose (Medwin Walk)
  - Lights in the Sainsbury's basement level car park at the Forum and 2 lights on the Forum were not working.
  - The lights in the Carfax were not coming on in the evenings.
  - Missing door (Piries Place car park)
  - Fire door stuck in an open position (Forum car park)
  - Broken casing which is presenting a trip hazard (Forum)
  - Loose paving slab causing a trip hazard (Bishopric)
  - o Pedestrian crossing button not working (Albion Way/Bishopric crossing). WSCC sent an engineer to investigate the problem.
