We also met with YMCA Staff and are working towards supporting their residents.

Patrols (foot and bike patrol)

All our patrols have been on foot, awaiting warmer weather to use our bikes. This has given us an opportunity to recharge the batteries ready for Spring.

We have patrolled green spaces and engaged with dog walkers.

Older, Vulnerable People and Young People

We completed a WSCC Adult Services Referral for an older male, who stopped us and disclosed information regarding their personal home life and finances. We also reported these details to Sussex Police. (Denne)

I have supported colleagues at Hurst Road Youth Café and handed out free hot beverage tokens during Half Term. (Denne)

We have met with various street drinkers and checked on their welfare. We have reminded them of the PSPO for Causeway and have asked them to leave. (Denne)

Charlie and I have liaised with Turning Tides regarding reports of a homeless person to aid support for them. (Denne)

Charlie and I provided a SCAMS Prevention Talk at Homestream House, we spoke to numerous members and shared our resources. (Denne)

We provided a welfare visit to an older person (Trafalgar).

We provided a uniformed patrol around Millais and Forest School, engaging with pupils and staff (Forest).
