ASB/Crime/Criminal Damage

We have seen a large number of youths congregating in the stairwells and top levels of The Forum and Swan Walk Car Parks. We have engaged with them and asked them to leave. We reported to Sussex Police graffiti and criminal damage to stairwell. We have worked closely with PCSOs and youth officer to share information and support identifying these individuals.

There has been an increase in graffiti in and around town which has been reported.

We have reported 18 hazards across all three Neighbourhood Councils from collapsed safety signs to broken fire doors.

Community engagement/events/meetings

We attended Primary Care Network's Cost of Living Drop In and held a point of access for members of the public and local businesses to ask us questions, get support and advice. Charlie and I offered a safety talk for Trinity Ladies Club and introduced them to our role. Charlie and I were invited to Roffey Place and enjoy their celebrations of opening with residents and staff. We met Gemma at Hurst Café and discussed projects.

Older, Vulnerable People and Young People

Charlie and I have met with lots of our vulnerable street drinkers and provided them with opportunities for support with food, finances, and addiction. We assisted Turning Tides' outreach worker to support clients presenting as


homeless in town. We have engaged with large numbers of young people and continue to recommend Hurst Café as a great place to go.

Cycling

We have asked several cyclists to dismount predominantly on West Street, again we have raised this with WSCC Highways as the signage is unclear. Members of the public also share their concerns and worries.

Patrols (foot and bike patrol)

We continue to provide foot patrols, here is a snapshot from 5 days' worth of patrol, our footprint tracks our location, and keeps us safe.



Case Study

We met a young person who had self-harmed and was in a distressed state, we were able to provide support and take them home to meet with family who were very grateful that we were able to do this. We worked collaboratively with Sussex Police to ensure this young person made it home safely to their parents where they were welcomed with open arms.
