Anti-Social Behaviour (ASB)

As Neighbourhood Wardens (NW) we have regularly patrolled with our PCSOs and continued to share information with them.

We have seen an increase in graffiti and continue to report all incidents to Sussex Police. We also reported a sighting of a man who was later arrested by Sussex Police.

We have shared relevant information with partner agencies to aid in the prevention and reduction of Anti-Social Behaviour (ASB) related incidents within town centre. We have supported a few residents with advice and guidance for those having difficulties with their neighbours and community around them. We continue to encourage members of the public to report all incidents to Sussex Police's website: - https://www.sussex.police.uk/ro/report/

We continue to encourage the use of the DISC app which allows businesses to report any ASB or theft in their stores. They then also report to the police. This has been very successful in getting businesses to communicate with each other and creating Police reports.

Community engagement/events/meetings

This month we met Ben Applin, the Rural Engagement Officer for West Sussex Fire and Rescue Service, he did a fantastic presentation on fire safety in the home to a carers support group at Horsham Library. It was great to meet both Ben Applin and the carers support group who have invited us back to discuss our role.

As Neighbourhood Wardens we frequently link in with Horsham Market which now has stalls on a Thursday, Friday, and Saturday. We are sure Horsham Town will continue to get busier throughout the summer months.

The Multi-Agency 'Turning Tides' meeting took place at Parkside building. This provided an opportunity for Horsham District Council's Housing team, West Sussex County Council's Adult Services, Turning Tides Outreach workers and Sussex Police to come together and formulate plans regarding individuals of concern. The NW provide a summary of what is seen 'on the ground level'.

We joined an outreach worker from Turning Tides to assist with the early morning headcount at 6am. We made contact with rough sleepers and signposted them towards services that can help them.

We have also supported several vulnerable people this month, this has included delivering food parcels and signposting to the foodbanks and community fridge. We encourage members of the public to support local charities such as Horsham Matters https://www.horsham-matters.org.uk/ and Turning Tides https://www.turning-tides.org.uk/ should they wish to donate to support anyone they believe to be homeless.

We engaged with a group of youths who were enjoying the outdoor space and provided guidance around personal safety and sharing public spaces.

Cycling

This month we have asked 6 cyclists to dismount on West Street, 5 of these dismounted and 1 cyclist refused to dismount. We continue to educate cyclists and asked them to dismount when observed on pavements and pedestrianised areas. This is predominant in West Street. We are working with WSCC Highways to address some of these issues. There continues to be a growing number of bikes thefts across the town, members of the public can order their own anti-theft stickers from The Bike Register https://www.bikeregister.com/
