# Anti-Social Behaviour (ASB)

As Neighbourhood Wardens (NW) we have regularly patrolled with our PCSOs and continued to share information with them. We completed 12 joint patrols with our local Town Team.

We have shared relevant information with partner agencies to aid in the prevention and reduction of Anti-Social Behaviour (ASB) related incidents within the town centre. We have supported a few residents with advice and guidance for those having difficulties with their neighbours and community around them. We continue to encourage the use of the DISC app which allows businesses to report any ASB or theft in their stores. They then also report to the police. This has been very successful in getting businesses to communicate with each other and creating Police reports. We patrolled with the BID Ambassador supporting local businesses in town centre.

### Community engagement/events/meetings

#### **Street Briefing - New Street**

PCSO Christina Laws lead a Street Briefing in New Street with the Horsham District Council Community Safety team and Youth Team. We spoke with residents about the local issues and supported them to fill out questionnaires so we can gain a greater understanding about the issues and how the residents would like us to combat these. Thank you to the representatives of Forest Neighbourhood Council who came along to support this. We shall be holding a second Street Briefing on January 15<sup>th</sup> 14:00 – 16:00 and we would encourage all residents to come and say hello.

#### **Multi-Agency Road Safety Event**

We were out in Horsham Town Centre alongside West Sussex Fire and Rescue Service, Sussex Safer Roads Partnership and Sussex Police for a multi-agency engagement event aiming to highlight road safety, especially over the festive period. This provided us with a great opportunity to engage and signpost residents and introduce our role.

We also attended the Care UK Networking Breakfast where we met with other professionals and exchanged contacts. This was a wonderful opportunity to stay up to date with the support and services available to our older population.
